ANTIGEN DISTRIBUTION AND SPECIFICITY:

The CDLLc antigen is the alpha chain of the integrin heterodimer of pl5D/95 kDa molecular weight. The CDLLc antigen is expressed on the majority of monocytes (>98%), granulocytes, and NK cells. This antigen is found on majority of hairy cell leukemias and is expressed weakly on T cell and B cell subsets (1%).

CLONE:

ANTIGENIX AMERICA clone 39, purified from murine ascites fluid.

Immunoglobulin chain composition: MOUSE IgGL, kappa light chains.

CONJUGATION:

Fluorescein isothiocyanate; R-Phycoerythrin.



HANDLING AND STORAGE:

All reagents are supplied as 1.0 mL of liquid, (0.5 mL for 50-test version). Fluorochromes should be protected from prolonged exposure to light. Reagents will be in a medium containing 0.01M phosphate-buffered saline, pH 7.4, 0.2% gelatin and 0.1% sodium azide. For flow cytometry use 10 uL per test to stain no more than one million cells. These preparations should be diluted in a protein-containing or other stabilizing medium to a concentration suitable for use in specific protocols. All reagents in a liquid state should be stored dark, at 2-8° C when not in use.
