### ■ Formulation

Mouse monoclonal anti-human **CACYBP** antibody in PBS (3.0 mM KCl, 1.5 mM  $\text{KH}_2\text{PO}_4$ , 140 mM NaCl, 8.0 mM  $\text{Na}_2\text{HPO}_4$  (pH 7.4)) containing 1% bovine serum albumin (BSA) and 0.05% sodium azide ( $\text{NaN}_3$ ).

### ■ Antibody concentration

100  $\mu\text{g}/\text{ml}$  (1.0 ml)

### ■ Storage

Store at 2-8°C for up to one year.  
We recommend storing at -20°C for long-term storage.  
Avoid repeat freezing and thawing cycles.

### ■ Preparation

This antibody was purified using protein G column chromatography from culture supernatant of hybridoma cultured in a medium containing bovine IgG-depleted (approximately 95%) fetal bovine serum.

### ■ Sterility

Filtered through a 0.22  $\mu\text{m}$  membrane.

### ■ Applications

WB, IC, Dot Blot, FC

### ■ Disposal

This antibody solution contains sodium azide ( $\text{NaN}_3$ ) as a preservative. There is a potential hazard that  $\text{NaN}_3$  reacts with copper or lead to produce an explosive compound. For safe disposal, the vial has to be washed thoroughly with water.

### ■ Safety warnings and precautions

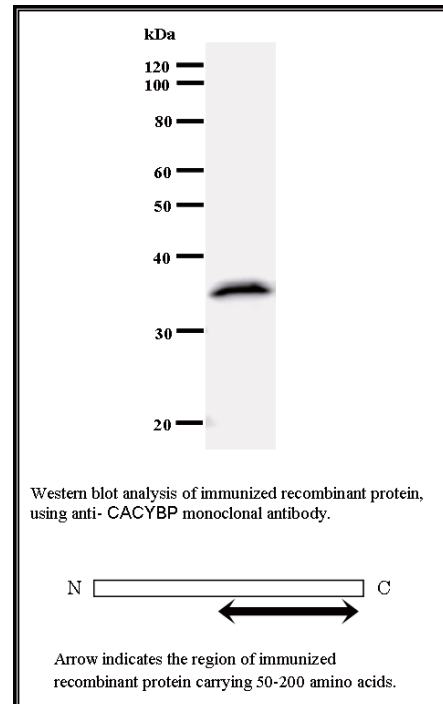

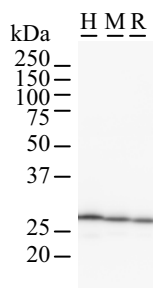
### Background

The protein encoded by this gene is a calcyclin binding protein. It may be involved in calcium-dependent ubiquitination and subsequent proteosomal degradation of target proteins. It probably serves as a molecular bridge in ubiquitin E3 complexes and participates in the ubiquitin-mediated degradation of beta-catenin. Two alternatively spliced transcript variants encoding different isoforms have been found for this gene. [NCBI Entrez Gene Summary]

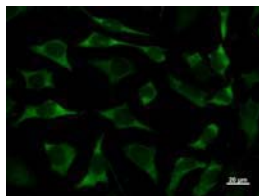
### Application



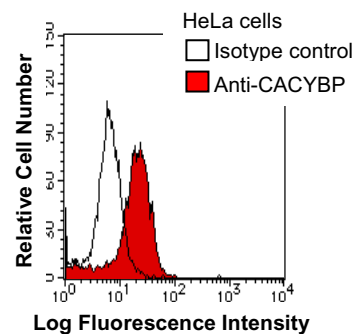
Detection of CACYBP by Western blot.

Samples: Whole cell lysate from human HEK293 (H, 25 µg), mouse NIH3T3 (M, 25 µg) and rat F2408 (R, 25 µg) cells. [Lot No. 2103C3a-1]

Predicted molecular weight: 26 kDa



Immunostaining analysis in HeLa cells. HeLa cells were fixed with 4% paraformaldehyde and permeabilized with 0.1% Triton X-100 in PBS. The cells were immunostained with anti-CACYBP mAb. [Lot No. 2103C3a-1]



HeLa cells were fixed in 2% paraformaldehyde/PBS and then permeabilized in 90% methanol. Cells were stained with anti-CACYBP mAb (shaded) or isotype control (unshaded) followed by Alexa Fluor® 488-conjugated goat anti-mouse IgG. [Lot No. 2103C3a-1]
