PLEASE FOLLOW THE ACCOMPANYING PROCEDURE WHEN RECEIVED TO INSURE THAT THE MATERIAL IS ACTIVE.

MATERIALS REQUIRED:

- 1. Nitrocellulose strip impregnated with appropriate antigen (1 µg/spot) - included.
- 2. 900 µl 1% BSA in PBS, pH 7.4.
- 100μl gold conjugate.

If less reagent is used, please keep proportions constant.

BLOTTING PROCEDURE:

- 1. Wet the nitrocellulose by adding 900 µl 1% BSA/PBS to the vial containing the strip.
- 2. Add 100 µl of the gold conjugate to the vial.
- 3. Incubate at room temperature for 1 hour with gentle agitation. Make sure the strip is kept immersed in solution.
- 4. Check the center of the strip for a reddish-pink dot. If no color appears, continue incubating overnight with gentle agitation.

NOTE:

The outer portion of the nitrocellulose has been blocked with BSA and acts as a negative control. No color should appear in this area. 5nm conjugates are difficult to see and generally give a lighter colored dot. If there is no reaction, please contact EY Laboratories, Inc.
